Visitor Management System



Feature of Visitor Management System

- Get temperature of the visitor and employees/tenants during registration
- Record visitor details into the VMS from the MyKad and Passport
- Record visitor details and temperature into VMS
- If temperature exceed the threshold. Alert security guard and block registration.
- Send alert to manager via Notifier App or SMS.
- Multi site synchronization to other VMS system.

Advantages of Visitor Management System

- Automated Face Recognition and Temperature capture of Visitor and employees/tenants during registration
- Records and Stores visitors & employees details into the VMS Server for Governmental Compliance for up to 6 months
- Digitisation and Easy to search and compile records
- Non-exposure to infection as compared to manual temperature recording
- Better Efficiency with Non-requirement of Guards / HR to capture temperature
- Eliminate Human Error in recording details & temperatures
- Immediate Notification of high temperature visitors and employees.



People Counting System




Feature of People Counting System

- Get the number of people in the premises / store / area
- Display the count at the entrance.
- Advise the customer to WAIT or ENTER
- Temperature check at the entrance with face capture
- Remote monitor on the number of visitors entering the site based on hourly / daily / weekly / Monthly
- If temperature exceed the threshold, advise visitor not to enter and alert the guard.
- Send alert to manager via Notifier App or SMS.

Access Control With Temperature Capture

Access Control Reader with FR



Feature of Access Control

- Get the number of people in the premises / store / area
- Record visitor and temperature into Access Control. Note Temperature will be recorded into a separate system.
- If temperature exceed the threshold. Alert security guard and block access.
- Send alert to manager via Notifier App or SMS.
